REPORT ON 10th MOOT COURT COMPETITION

The 10th Moot Court Competition of Bishop Cotton Women's Christian Law College "Prudentia Conscientia Ingenium Occursus," (Wisdom ,Knowledge and Talent Meet)was scheduled from 25th to 27th April 2025 with the intention to bring law students from across the country with the objective of providing a dynamic platform for law students to showcase their advocacy, research, legal drafting skills, critical thinking and professionalism.

The Moot Court problem for this year centered around Public International Law, with particular focus on asylum and extradition, this topic was selected to encourage the participants to engage in real world legal dilemmas on a global scale. To ensure the problem's accuracy, relevance and legal depth,subject matter experts in internation law like Dr Banerjee Chakka , Dean and Professor of Law

The competition had 16 teams , to ensure a knowledgeable assessment, a panel of 35 judges, 16 for the Preliminary Round, 8 in Quarter Final , 6 in Semi Finals and 5 in the Final Round specializing in the field of Constitutional Law and Public International law adjudicated the competition .

The competition was inaugurated on 25th April at 5:30 Pm by Chief Guest, Hon'ble Mr. Justice Ashok G. Nijagannavar, Former Judge, High Court of Karnataka , MemberLaw Commission of Karnataka and the Guests of Honor, Mr. Devadas Sadhu ,**Karnataka Central Diocese graced the event.**





On 26th April 2025, at 8.45 am, the judges were given orientation and were led to their respective court halls. The first Preliminary Round began at 9:00 AM, followed by the second preliminary round at 11:30 AM. The competition featured a total of Eight court halls, with each round being judged by a Division bench.



Out of the 16 teams that participated in the preliminary rounds, eight teams successfully qualified for the Quarter-finals. Prior to the Quarter-finals, the judges received a briefing regarding the scoring criteria for the competition. The division bench responsible for adjudicating the teams in the Quarter-finals consisted of advocates specialized in Constitutional Law and scholars in the domain of Public International Law.



From the 8 teams by the rule of Knock out Four teams successfully qualified for the Semi-Finals. At 5 pm again, using Randomiser tool the order of the matches were determined and the teams exchanged their memorials in preparation for the Semi-Finals.

On 27th April, the Semi-Final rounds began with orientation on marking criteria to the Judges at 9.15 AM. The session started at 9.30 AM. A panel of three judges presided over the proceedings.
